Main Responsibilities:

- To deliver practical Games and PE lessons as well as theory for PE GCSE and A Level.
- To maintain a high level of First Aid knowledge and be comfortable delivering this in a range of environments as necessary
- To manage pupil learning through effective teaching in accordance with the Department's schemes of work and policies.
- To ensure continuity, progression and cohesiveness in all teaching.
- To use a variety of methods and approaches (including differentiation) to match curricular objectives and the range of pupil needs and abilities and ensure equal opportunity and enjoyment for all pupils.
- To set homework regularly, as appropriate, (in accordance with the School homework policy), to consolidate and extend learning and to encourage pupils to take responsibility for their own learning.
- To work with SEN staff and support staff (including prior discussion and joint planning) in order to benefit from their specialist knowledge and to maximise their effectiveness within lessons.
- To work effectively as a member of the Department team to improve the quality of teaching and learning.
- To arrange and attend fixtures both within the school day and as and when appropriate and guided by the Director of Sport, after hours and at weekends.
- To offer high quality and well planned extra-curricular clubs extending the sporting opportunities available to students.
